JOB SUMMARY

The Assistant Case Manager (ACM) works to support the Intensive Case Management (ICM) program at Four A's. Duties will include direct client interaction, administrative work and direct support of the ICM staff. The successful ACM candidate will have excellent verbal and written communication skills, judgement, critical thinking and a commitment to the guiding principles of the organization. The successful candidate will approach the work with curiosity and compassion and a collaborative, team-focused approach, whether working with an individual client, coworkers, or external community partners/providers. An ACM will possess a high level of expertise in fast-paced team-oriented workplace, scheduling, and workload, and be an excellent problem-solver and proactive communicator. This position is supported and supervised by the Case Manager Supervisor.

QUALIFICATIONS

<u>Education and Experience</u>: The successful candidate will have life experience, experience in social services or a bachelor's degree in nursing, human services, social services. Prefer experience working on HIV-related issues or with people who experience HIV. Lived experience with HIV, substance use, or PrEP is highly valued. Must be able to work occasional evenings and weekends as necessary.

<u>Communication Skills:</u> Must possess excellent written, communication, and organizational skills, be proficient in database entry and management with an attention to detail, have a positive attitude, possess strong listening skills, and feel comfortable working with diverse populations in a variety of settings. Must be comfortable discussing sex, sexual health, and sexuality.

ESSENTIAL JOB FUNCTIONS

- Serve as a support for clients who need immediate assistance when an ICM is not available.
- Provide comprehensive education on HIV/AIDS, treatment options, prevention strategies, and the impact of viral suppression.
- Promote sexual health and wellness via status-neutral approaches and evidencebased interventions.
- Transport clients to medical or other appointments.
- Represent the agency and provide information to the public on all organization services at external outreach events.
- Document all client interactions, interventions, and progress notes in accordance with program guidelines and requirements.
- Work with a team of Intensive Case Managers to provide services to all people living with HIV served by Four A's.
- Provide support for programs including Friday lunch, the food pantry, and other Four A's services.
- Maintain all physical and electronic client files.
- Actively participate in department meetings, QI/QM projects, events, bringing a positive, solution-based approach to challenges.
- Actively participate in facilitating a welcoming, affirming, and compassionate culture of healing within the organization.
- Proactively seek out new resources, information, and opportunities that would benefit PLWH.
